Budget

Anticipated no. of funded groups	15-20 (anticipated 0.3 – 0.4 Mio. € per group)
Fundable costs	Direct project costs, (i.e., personnel; consumables; animal costs; equipment; subcontract; travel) and overhead costs.

<u>Funding rates</u> for universities, university hospitals and nonuniversity research institutes can be up to 100% of their costs. Industry can be funded with a maximum of 50-60% of their cost.

<u>Personnel costs</u> must be calculated according to the specific labour agreement that is valid for an institution or company. Only personnel costs for scientific activities can be funded (i.e., no costs for pure administration or project coordination will be funded). For universities, university hospitals and non-university research institutes, no costs for permanent stuff can be funded.

<u>Consumables and equipment</u> can be funded as long as costs are directly related to the project (e.g., no basic infrastructure or standard office supplies will be funded).

<u>Travel costs</u> for project meetings and conferences should normally not exceed 2000€ per year and per full-time position. Higher travel costs can only be funded if they are well justified.

<u>Subcontracts</u> can be funded if an additional expertise or service is needed and subcontracting is justified. However, it is not allowed to increase the number of partners of a consortium due to subcontracting of work packages (please note that for patient recruitment, e.g., for cohort studies, specific regulations might apply). Subcontracting to contractors in other countries (i.e., outside Germany) must be well justified and is only possible if no comparable expertise is available in Germany.

Overheads are eligible according to standard BMBF regulations. For universities and university hospitals please note that overheads ("Projektpauschale") will increase from currently 20% to 22% in 2016ff of total project costs.
