The maximum indirect costs set for the present call are 25 % (flat rate) of direct costs without the sub-contracting.</b> The aid intensity for activities carried out by a research organisation might be at the level of 100 % provided that the research organisation complies entirely with requirements stipulated by the Article 2.1.1 "Public funding of non-economic activities" of the Framework for State Aid for Research and Development and Innovation (2014/C 198/03) and proves it by means of the above-mentioned Statutory Declaration.
