Eligibility for the 1001 Scientific and Technological Research Projects Funding Program

Eligible Institutions	The funding is granted to Principal Investigators from universities, public or private sector. The PI and researchers are subject to eligibility check.
Additional requirements	<p>Participants from Turkey should also submit their proposals to TUBITAK electronically via ardeb-pbs.tubitak.gov.tr by 18th of March for pre-proposals (in Turkish) and 1st of July for the full proposal stage (in English). The signed hard copies should be sent to, TUBITAK UİDB Tunus Cad No:80 06100 Ankara within one month of the online submission.</p> <p>Project Manager, Researchers and Advisors:</p> <ul style="list-style-type: none"> - University personnel should have a PhD degree. - Those working in a public institution or a private corporation should have an undergraduate degree. - Except advisors, the project manager and researchers should reside and work in Turkey. - A researcher should have a contribution of at least 10% of the project workload. - An advisor is allowed if the project requires special expertise on a specific subject. The number of advisors in a project is limited to the number of specific subjects in the project. The role of advisor in the project should be explained in detail in the project proposal. <p>NOTE: University rectors and vice rectors, deans, head of</p>

	<p>academy/institute, surgeons general, general secretaries, general managers, state department heads and members of the executive committee/advisory board of TÜBİTAK groups cannot be the project manager in any project if they are working in those positions as of the application date. Eligibility for the TUBITAK 1509 International Industrial R&D Projects Funding Programme and/or TUBITAK Innovation Support Programme

Eligible Institutions	<p>TÜBİTAK's 1509-International Industrial R&D Projects Funding Program funds innovative R&D projects of private companies in Turkey that participate in international joint programs. All SMEs or large enterprises established in Turkey can apply to the program. Academic institutions and other R&D institutes (including non-for-profit research institutes recognized by TÜBİTAK) must participate the projects as subcontractors of SMEs or large enterprises and are covered under the partner's budget.</p> <p>Funding rates: SMEs can receive funds as 75% of all eligible R&D costs and large companies receive funds as 60 % of all eligible R&D costs.</p> <p>Major eligibility restrictions: The only precondition for companies to apply for this program is to</p>

Industrial research and experimental development phase of R&D is funded and the following sub-phases of these activities are eligible:</p> <ul style="list-style-type: none"> • Conceptual development, • Technological/technical and economic feasibility studies, • Laboratory studies to be conducted in the process of transition from conceptual development to design, • Design and development, • Prototype production, • Establishment of pilot plant, • Test run.
