	In order to expedite the eligibility check process, the Ministry
	of Health will grant an eligibility clearance to the applicant
	prior to the submission of the proposals.
	To this end it is mandatory to return at least 10 working days,
	prior the proposal submission deadline to the JCS via the

IRCCS/ISS Scientific Directorate WFR System-> ER communication code, the filled <u>pre-submission eligibility check</u> Applicant will be sent a written notification of their eligibility status. Changes of acronym and budget provided in the presubmission eligibility check form are not allowed After the JPND 2 peer review process has been completed and a final (scientific) ranking list has been established and endorsed by the Call Steering Committee, the Ministry of Health will invite the principal investigators of the projects approved for funding to enter the formal national negotiations (according to national regulations). Submission of annual scientific and financial reports at the national level will be required according to the rules of the Ministry of Health. Further information on the rules of the Ministry of Health can be requested to the national contact persons.
