Eligibility

Eligible Institutions	Fundable: ONLY IRCCS - Scientific Institutes for Research, Hospitalization and Health Care (Istituti di Ricovero e Cura a Carattere Scientifico pubblici e privati) and ISS (Istituto Superiore di Sanità) No fundable: University, other research Institute, companies
Additional requirements	Two researchers belonging to Italy - Ministry of Health eligible Institutions are allowed to apply in the same consortia . One consortia, two researchers, will share the amount of 250.000€. The simultaneous participation in proposals submitted in 2021 for different transnational research calls funded by the Ministry of Health is not allowed to Italian Principal Investigators, including WP leaders. In order to expedite the eligibility check process, the Ministry of Health will grant an eligibility clearance to the applicant prior to the submission of the proposals. To this end it is mandatory to return at least 10 working days, prior the proposal submission deadline to the JCS via the

Submission of annual scientific and financial reports at the national level will be required according to the rules of the Ministry of Health.
