Eligibility

Eligible Institutions	<p>Projects must comply with the SNSF Project Funding regulations.</p> <p>All applicants and co-applicants seeking SNSF support must be eligible for SNSF Project Funding. Project Funding. Please note that applications submitted by a non-eligible person will not be considered nor evaluated. Additional requirements	<p>Participation as Swiss applicant to the JPND call is restricted to one proposal per call.</p> <p>The SNSF exclusively funds research conducted for purposes that are not directly commercial. _ Pursuant to the Research and Innovation Promotion Act RIPA and the legal framework of the SNSF, no research grants are awarded if the relevant research is conducted for directly commercial purposes or if the persons involved in the research work are not scientifically independent.</p> <p>Forms to be submitted _ Swiss applicants must submit pre-proposals and full proposals via mySNF at the same deadline as the applications are submitted to the Call Secretariat and in addition to the documentation submitted to the Call Secretariat.</p>

	<p>_ Pre-proposal forms are created by choosing “Programmes (national and international): ERA-Net + EJP: Pre-proposal”.</p> <p>_ Full proposals forms are created by selecting “Programmes (national and international): ERA-Net + EJP” and linked to the pre-proposal by selecting its number in the data container “Link to other SNSF projects”.</p> <p><u>Partners</u></p> <p>_ Partners of the international project consortium applying for funding at funding agencies other than the SNSF cannot be declared as <i>'project partners'</i> in the sense of article 11.2 of the SNSF Funding Regulations. They are to be declared as <i>'consortium partners'</i> and apply for their funding at their respective research funding organisation.</p> <p><u>Data Management Plan (DMP)</u></p> <p>_ In case of funding, applicants have to complete the DMP on <i>mySNF</i> once the project is approved, regardless of whether a DMP is requested by the consortium. Researchers need to develop a DMP that covers all data generated or used for the entire Collaborative Research Project (CRP). The DMP must comply with the SNSF policy on open research data and is mandatory for the release of funds for Swiss sub-projects. For further information, please refer to http://www.snf.ch/en/theSNSF/research-policies/open_research_data/Pages/default.aspx</p> <p><u>Consortium agreement (CA)</u></p> <p>_ In case of funding, applicants have to submit a CA signed by all regular partners of the proposal. Submission of the CA is mandatory for the release of funds for Swiss sub-projects.</p> <p><u>Material check and overlapping SNSF projects</u></p> <p>_ Besides the eligibility check, the SNSF proceeds to a material check. This refers to the applicant’s experience and research activity during several years as well as the demonstration of their scientific independence (Art. 4, Project funding regulations).</p> <p>Although the JPND grant does not count into the maximal number of grants that an investigator can hold in SNSF project funding, in case of several overlapping SNSF projects, all projects must significantly distinguish themselves from each other (Art. 13.2 & 13.3, Project funding regulations).</p>
